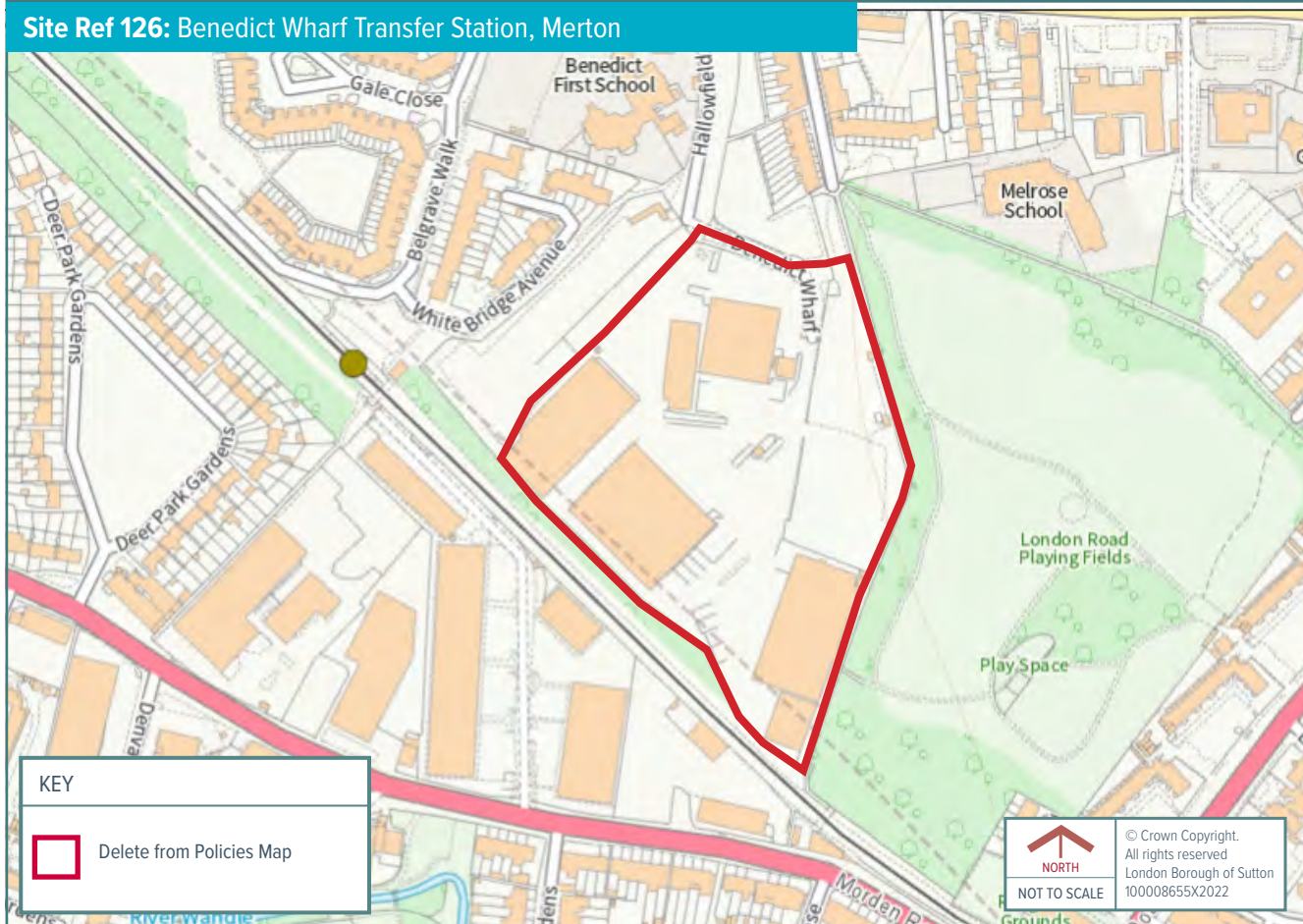

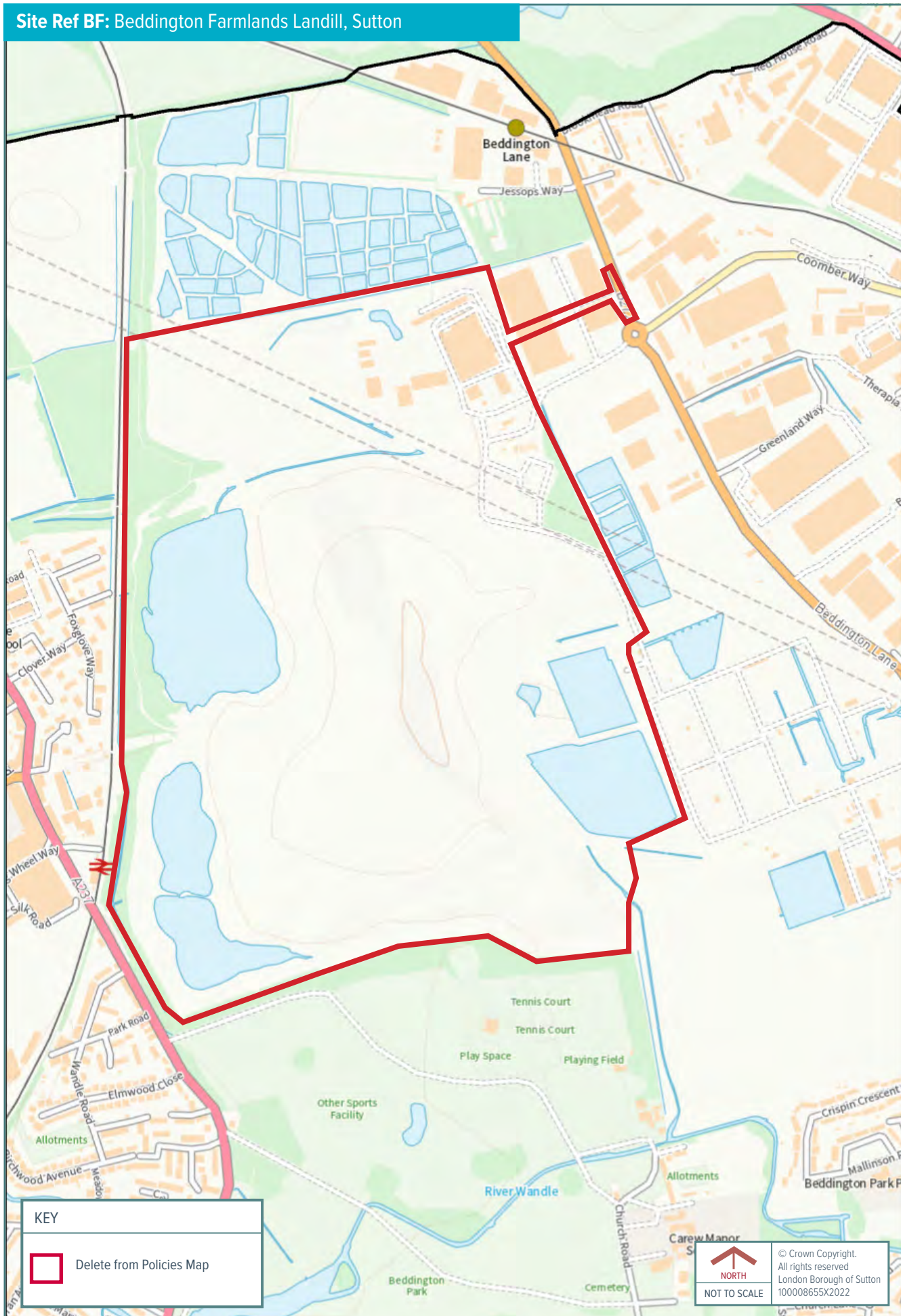

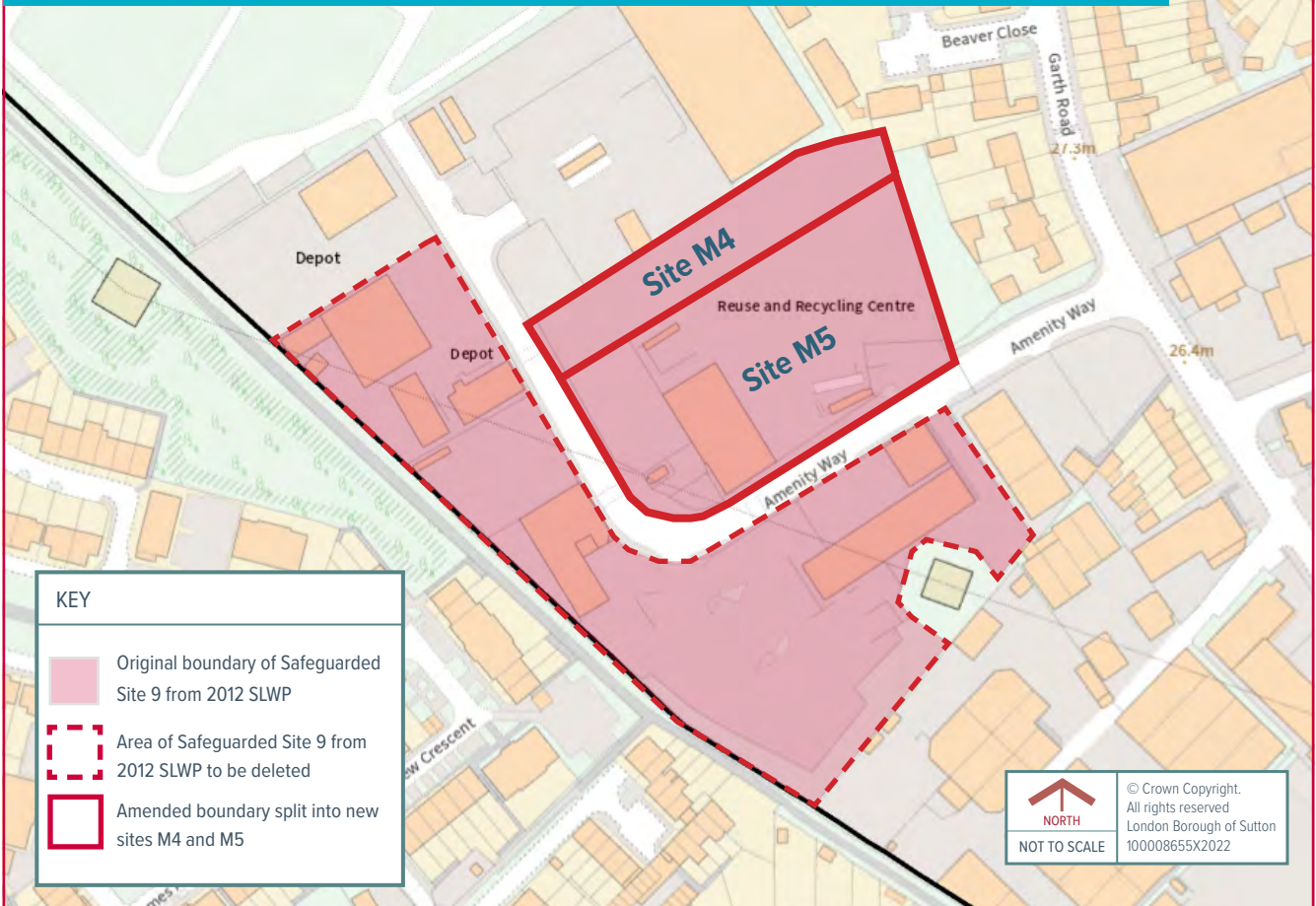
Safeguarded Sites from the 2012 South London Waste Plan with Policies Map Boundary Amendments



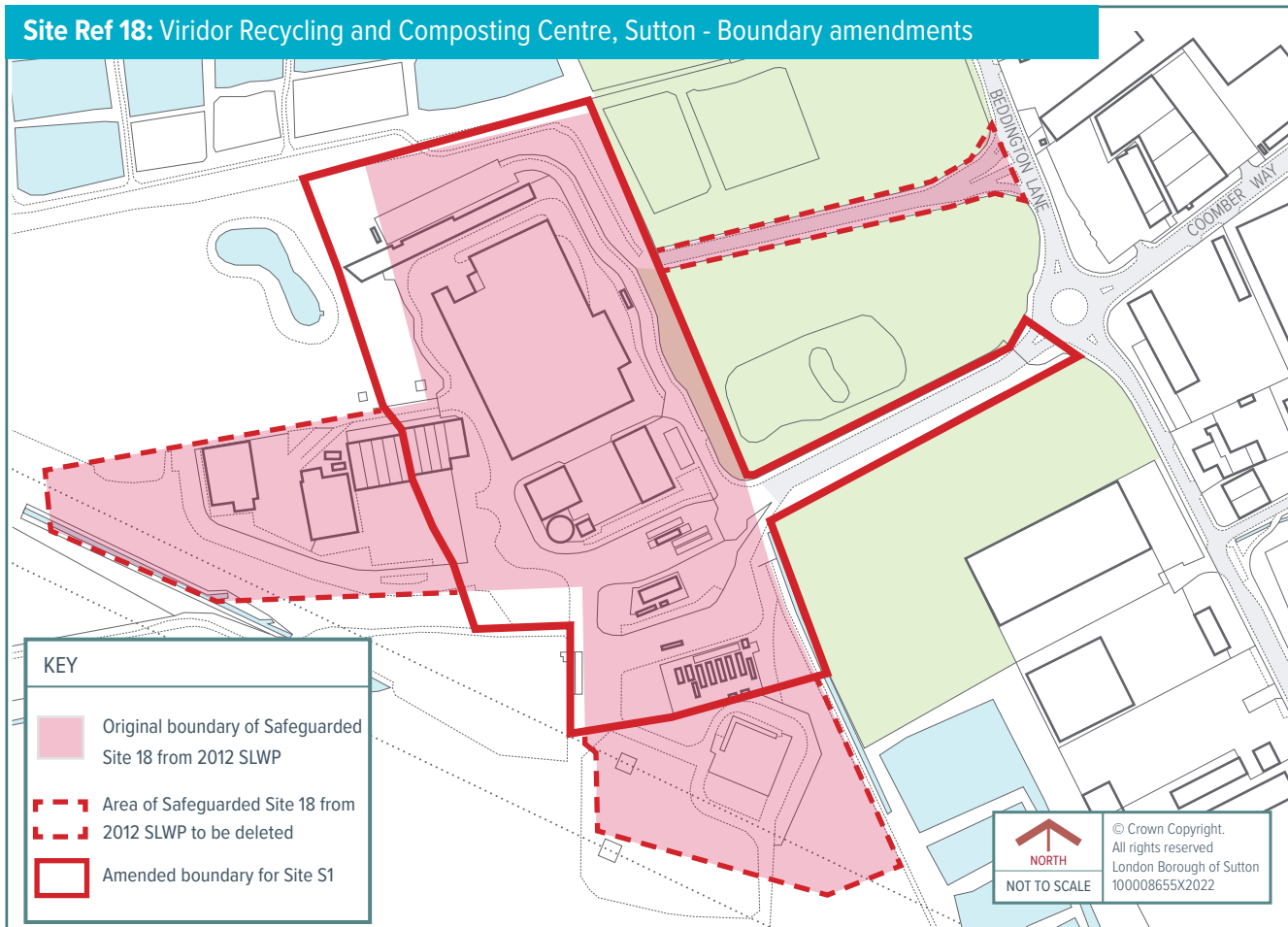

Site Ref Area 99: Purley Oaks Highways Depot, Croydon - Delete from Policies Map



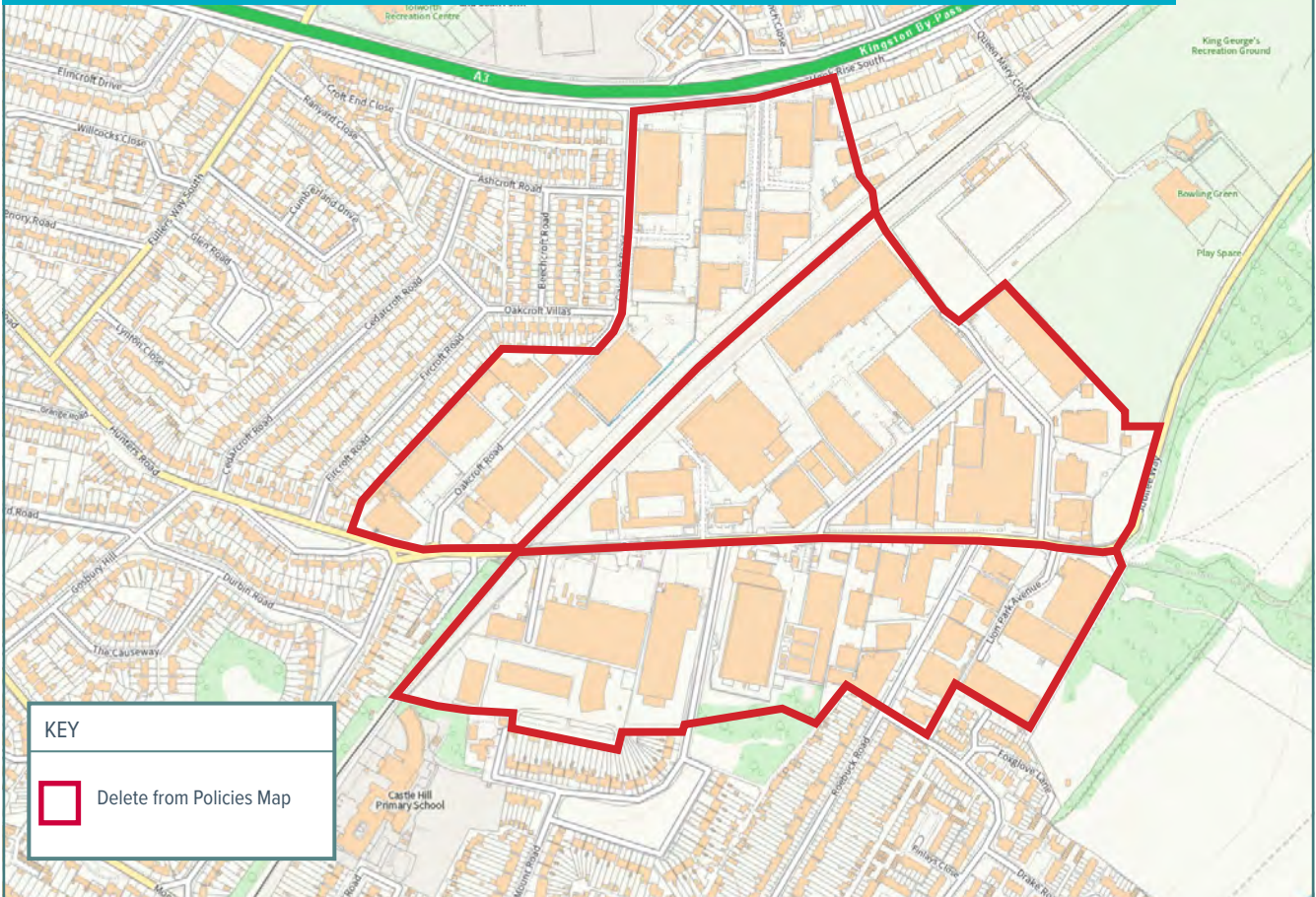
