

DISABLED PERSONS PARKING PLACES – SCHEDULE 234

The Croydon (Prohibition and Restriction of Stopping, Loading and Waiting) and (Free Parking Places)
(Amendment No. F39) Order 20-

The Croydon (On-Street Charged-For Parking Places) (Amendment No. F40) Order 20-

NOTICE IS HEREBY GIVEN that Croydon Council proposes to make the above Traffic Orders under section 6 of the Road Traffic Regulation Act 1984, as amended and all other enabling powers.

1. The general effect of the Orders would be to:

- a) Revoke the disabled parking places in the vicinity of No. 96 Dalmally Road, Croydon, No. 574 Davidson Road, Croydon, No. 167 Fairlands Avenue, Thornton Heath, No. 21 Grangecliffe Gardens, South Norwood, No. 156 Langdale Road, Thornton Heath, 19 Lismore Road, South Croydon, No. 18 Lucerne Road, Thornton Heath, No. 22 Mayfield Road, South Croydon, No. 217 Mersham Road, Thornton Heath, No. 45 Norton Gardens, Norbury, No. 60 Raymead Avenue, Thornton Heath, No. 1 Trafford Road, Thornton Heath, No. 33 Watcombe Road, South Norwood, No. 3 Westleigh Avenue, Coulsdon, and No. 20 Woodside Road, South Norwood.
- b) Designate new parking places at which vehicles displaying a disabled persons' badge may be left without charge or time limit in the following locations.

Beech Road, Norbury	Outside No. 7
Cator Close, New Addington	On the north side of the turning area adjacent to lamp column No. 004
Charnwood Road, South Norwood	Outside No. 16 and partially across the frontage of No. 18
Cheston Avenue, Croydon	Outside Nos. 151 and 153
Constance Road, Croydon	Outside Nos. 17 and 19 (replaces one space in a permit/payment bay)
Cooper Road, Croydon	Outside Nos. 6 and 8 adjacent to the existing disabled bay
Drover's Road, South Croydon	Outside Nos. 33 to 39 (replaces one space in a permit/payment bay)
Gonville Road, Thornton Heath	Outside No. 70
Isham Road, Norbury	Outside No. 7 and partially across the frontage of No. 9
Livingstone Road, Thornton Heath	Outside No. 124 and partially across the frontage of No. 126
Lynwood Gardens, Croydon	Outside No. 10
Maxwell Close, Croydon	Outside No. 20
Norbury Avenue, Thornton Heath	Outside No. 159
Redstart Close, New Addington	Outside Nos. 2 and 4 (adjacent to existing disabled bay)
St. Andrew's Road, Croydon	Outside No. 11 and partially across the frontage of No. 12 (replaces one space in a permit/payment bay)
Strathmore Road, Croydon	Outside Nos. 21 and 23 (replaces one space in a permit/payment bay)
Tirrell Road Croydon	Outside No. 15 (replaces one space in a permit/payment bay)

- c) Amend the map-based tiles to the Schedule attached to the above Orders to accurately represent the new parking arrangements as they exist on site.
2. A copy of the proposed Orders and all related documents can be inspected between 9am and 4pm, Monday to Friday inclusive, until the last day of a period of six weeks beginning with the date on which the Orders are made or, as the case may be, the Council decides not to make the Orders, by appointment with the Parking Design Team, at Bernard Weatherill House, 8 Mint Walk, Croydon, CR0 1EA (telephone 020 8726 6000 and ask for Parking Design).
