

**DISABLED PERSONS PARKING PLACES – SCHEDULE 235**

The Croydon (Prohibition and Restriction of Stopping, Loading and Waiting) and (Free Parking Places) (Amendment No. F49) Order 20-

The Croydon (On-Street Charged-For Parking Places) (Amendment No. F50) Order 20-  
NOTICE IS HEREBY GIVEN that Croydon Council proposes to make the above Traffic Orders under section 6 of the Road Traffic Regulation Act 1984, as amended and all other enabling powers.

**1. The general effect of the Orders would be to:**

- a) Revoke the disabled parking places in the vicinity of No. 14 Buller Road, Thornton Heath, No. 156 Cecil Road, Croydon, No. 13 Cypress Road, South Norwood, the junction of Norbury Crescent in Ederline Avenue, Norbury, No. 26 Heather Way, South Croydon, No. 15 Homer Road, Shirley, Croydon, No. 18 Hunter Road, Thornton Heath, No. 7 Imperial Way, South Croydon, No. 51 Lucerne Road, Thornton Heath, No. 128 Morland Road, Croydon, and No. 172 Norbury Avenue, Thornton Heath.
- b) Designate new parking places at which vehicles displaying a disabled persons' badge may be left without charge or time limit in the following locations.

Beulah Grove, Croydon	Outside No. 33 and partially across the frontage of No. 34 (replaces one space in a partial footway permit/payment bay)
Cecil Road, Croydon	Partially outside Nos. 47 and 49 (replaces one space in a permit/payment bay)
Crowther Road, South Norwood	Outside No. 78 (replaces one space in a permit/payment bay)
Ederline Avenue, Norbury	At a point 27 metres south-west of the north-eastern boundary of No. 168 Norbury Crescent (replaces the existing bay adjacent to the junction of Norbury Crescent)
Harcourt Road, Thornton Heath	Outside No. 29 and partially across the frontages of Nos. 27 and 31, extending the existing bay to 7 metres in length (replaces one space in a permit/payment bay)
Harrington Road, South Norwood	Outside No. 178 and partially across the frontage of No. 176
Hartley Road, Croydon	Outside No. 43 and partially across the frontage of No. 45 (replaces one space in a permit/payment bay)
Junction Road, South Croydon	Adjacent to the flank wall of No. 63 Brighton Road next to an existing disabled bay (replaces one space in a permit/payment bay)
Langdale Road, Thornton Heath	Outside No. 41
Lansdowne Road, Purley	Outside No. 3 and partially across the frontage of No. 5
Larch Tree way, Croydon	Opposite No. 18
Orchard Rise, Croydon	Outside No. 48
Ringwood Avenue, Croydon	Outside No. 76
Thorpe Close, New Addington	Adjacent to the footpath next to Nos. 44 to 58 Thorpe Close
Waddon Road, Croydon	Partially outside Nos. 119 and 121 (replaces one space in a partial footway permit/payment bay)
Warbank Crescent, New Addington	Outside Nos. 71 to 89
Westleigh Avenue, Coulsdon	Outside No. 127
Woodside Avenue, South Norwood	Outside No. 26 and partially across the frontage of No. 24

- c) Amend the map-based tiles to the Schedule attached to the above Orders to accurately represent the new parking arrangements as they exist on site.
2. A copy of the proposed Orders and all related documents can be inspected between 9am and 4pm, Monday to Friday inclusive, until the last day of a period of six weeks beginning with the date on which the Orders are made or, as the case may be, the Council decides not to make the Orders, by appointment with the Parking Design Team, at Bernard Weatherill House, 8 Mint Walk, Croydon, CR0 1EA (telephone 020 8726 6000 and ask for Parking Design).
