**PROPOSED INTRODUCTION OF NEW OR AMENDMENT OF EXISTING PARKING BAYS**  
**WAITING RESTRICTIONS & SCHOOL KEEP CLEAR**  
**VARIOUS LOCATIONS WITHIN THE LONDON BOROUGH OF CROYDON**

The Croydon (Prohibition and Restriction of Stopping, Loading and Waiting) and (Free Parking Places) (No.5) Order 2024

The Croydon (On-Street Charged-For Parking Places) (No.5) Order 2024

1. NOTICE IS HEREBY GIVEN that Croydon Council on 11 March 2024 made the above Traffic Orders under the relevant sections of the Road Traffic Regulation Act 1984 as amended and all other enabling powers.
2. **The general effect of the Orders would be:**
  - (a) To introduce new or amend existing parking places, waiting restrictions and School Keep Clear restrictions in the locations detailed in the Schedule to this Notice.
  - (b) To adjust existing restrictions to accommodate the new or amended arrangements where necessary.
  - (c) To amend the map-based tiles to the Schedule attached to the above Orders to accurately represent the new parking arrangements as they exist on site.
3. Copies of the Orders, which will come into operation on 18 March 2024 and of all associated Orders can be inspected between 9am and 4pm on Mondays to Fridays inclusive until the end of six weeks from the date on which the Orders were made, by appointment with the Parking Design Team, at Bernard Wetherill House, 8 Mint Walk, Croydon, CR0 1EA (telephone 020 8726 6000 and ask for Parking Design).
4. Copies of the Orders may also be obtained from Parking Design, 6<sup>th</sup> Floor Zone C, Bernard Weatherill House, 8 Mint Walk, Croydon CR0 1EA (email: parking.design@croydon.gov.uk).
5. Any person desiring to question the validity of the Orders or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act, 1984 or that any of the relevant requirements thereof or of any relevant regulations made there under have not been complied with in relation to the Orders may, within six weeks of the date on which the Orders were made, make application for the purpose to the High Court.

<b>Street Name</b>	<b>Type Of Bay</b>	<b>Details</b>
Central Parade, New Addington	Electric Vehicle (EV) Charging Bay	The east side, outside No. 1, removing a length of single yellow line to extend the existing EV bay by 3.1 metres northwards to make it 9m in length.
Coldharbour Road, Croydon	Car Club Bay	The south side, outside No. 130, introducing a 5-metre partial footway car club bay.
Fairdene Road, Coulsdon	Resident Permit Holders' Only Bays	The south-east side, removing a length of single yellow line to extend the resident permit bay outside No. 39 by 5 metres north-eastwards.

Hastings Road, Croydon	Permit/Payment Bays	The north-west side, removing a length of single yellow line and extending the existing bay by 15.5 metres south-westwards so that it finishes outside No.11.
Oliver Grove, South Norwood	Permit/Payment Bays & Loading Bay	<p>The south-west side.</p> <ul style="list-style-type: none"> <li>• Removing one permit/payment parking space opposite No. 8 and the loading bay opposite No. 6.</li> <li>• Removing the existing School Keep Clear and relocating it opposite Nos. 4 to 8.</li> <li>• To introduce one additional 5-metre permit/payment bay opposite No.2.</li> </ul>

Reddown Road, Coulsdon	Resident Permit Holders' Only Bays	<ul style="list-style-type: none"> <li>• The north-west side, removing four 10-metre lengths of single yellow lines and replacing them with four 10-metre bays outside Nos.72, 74, 76 and 84.</li> <li>• The north-west side, removing a length of single yellow line to extend the existing bay outside No. 34 by 15.5 metres south-westwards.</li> <li>• The south-east side, removing one 15.5-metre length of single yellow line and replacing it with a 15.5-metre bay outside Nos.71 and 73.</li> <li>• The south-east side, removing one 5.5-metre length of single yellow line to replace it with a bay outside No. 17, and removing a 10-metre length of single yellow line to replace it with a bay outside Nos. 21 and 23.</li> </ul>

Selsdon Road, South Croydon	3-Hr Max Stay Disabled Bay	The south-west side, removing one existing pay and display only space and a short length of double yellow lines outside Nos. 18 and 18C, extending the bay to 6 metres in length and converting it to a limited stay disabled bay.
