

**DISABLED PERSONS PARKING PLACES – SCHEDULE 236**

The Croydon (Prohibition and Restriction of Stopping, Loading and Waiting) and (Free Parking Places) (Amendment No. K4) Order 20-

The Croydon (On-Street Charged-For Parking Places) (Amendment No. K5) Order 20-  
NOTICE IS HEREBY GIVEN that Croydon Council proposes to make the above Traffic Orders under section 6 of the Road Traffic Regulation Act 1984, as amended and all other enabling powers.

**1. The general effect of the Orders would be to:**

- a) Revoke the disabled parking places in the vicinity of No. 52 Beverley Road, Whyteleafe, No. 112 Church Road, Upper Norwood, Nos. 13, 15, 29 and 47 Colliers Water Lane, Thornton Heath, No. 35 Ecclesbourne Road, Thornton Heath, No. 42 Elmside, Fieldway, New Addington, No. 10 Ena Road, Norbury, No. 62 Lucerne Road, Thornton Heath, No. 23 Mowbray Road, Upper Norwood, No. 32 Nova Road, Croydon, No. 31 Swallowdale, South Croydon, No. 47 Upwood Road, Norbury, and No. 148 Wentworth Way, South Croydon.
- b) Designate new parking places at which vehicles displaying a disabled persons' badge may be left without charge or time limit in the following locations.

Apsley Road, South Norwood	Outside No. 44 and partially across the flank wall of Nos 2a – 2c Seymour Place (relocation of existing bay outside Nos. 42 / 44)
Bavant Road, Norbury	Outside No. 5 and partially across the frontage of No. 7
Boswell Road, Thornton Heath	Outside No. 23 and partially across the frontage of No. 21 (partial footway bay)
Cobden Road, South Norwood	Outside No. 64
Donald Road, Croydon	Outside No. 55 and partially across the frontage of No.53, (replaces one space in a permit/payment bay)
Dundee Road, South Norwood	Outside No. 61 and partially across the frontage of No. 63
Ena Road, Norbury	Outside No. 17
Ferndale Road, South Norwood	Adjacent to the flank wall of No. 277 Portland Road
Hamilton Road, Thornton Heath	Outside No. 2
Homestead Way, New Addington	Opposite No. 152
Kemerton Road, Croydon	Opposite Nos. 39 / 41
Kilmartin Avenue, Norbury	Outside No. 111
Moffat Road, Thornton Heath	Outside No. 123 (partial footway bay)
Oswald, Court Wood Lane, Croydon	Outside No. 264 and partially across the frontage of No. 265
Parchmore Road, Thornton Heath	Outside No. 96 and partially across the frontage of No. 94
Portland Road, South Norwood	Outside Nos. 299 (replaces one space within a free parking bay)
Stroud Road, South Norwood	Outside No. 12
Tankerton Terrace, Mitcham Road, Croydon	Partially outside Nos. 1 and 2
Whitehorse Road, Croydon	Outside No. 177 (replaces one space in a partial footway permit/payment bay)
Woodville Road, Thornton Heath	Outside No. 116 and partially across the frontage of No. 114

- c) Amend the map-based tiles to the Schedule attached to the above Orders to accurately represent the new parking arrangements as they exist on site.
2. A copy of the proposed Orders and all related documents can be inspected between 9am and 4pm, Monday to Friday inclusive, until the last day of a period of six weeks beginning with the date on which the Orders are made or, as the case may be, the Council decides not to make the Orders, by appointment with the Parking Design Team, at Bernard Weatherill House, 8 Mint Walk, Croydon, CR0 1EA (telephone 020 8726 6000 and ask for Parking Design).
