## Croydon's Local Development Scheme

June 2024



#### Introduction

This document sets out Croydon Council's future programme of preparing and reviewing Croydon's Development Plan (excluding the London Plan, which is prepared entirely by the Mayor of London and not Croydon Council).

It also provides the links to the adopted Supplementary Planning Documents (which provide supporting guidance to the existing Croydon Local Plan 2018) and proposed Supplementary Planning Documents the Council intends to prepare following the adoption of the Local Plan Review.

For each document listed in this document the following information is provided:

- The title of the document;
- Whether the document itself is part of the Development Plan, or whether it is a Supplementary Planning Document to the Development Plan;
- Geographic scope of the document;
- The subject matter of the document;
- Whether the document is being prepared solely by Croydon Council or whether it is being prepared with other Local Planning Authorities; and
- The timetable for preparing the document.

#### Future Local Development Framework programme

Local Plan Partial Review

The Town and Country Planning (Local Planning) (England) (Amendment) Regulations 2017 introduced (as of 6<sup>th</sup> April 2018) a requirement to review Local Plans within five years of the adoption of the last local plan. As the Croydon Local Plan 2018 was adopted on the 27<sup>th</sup> February 2018, this means that a review of the Croydon Local Plan had to commence by 27<sup>th</sup> February 2023 and work is already underway.

The review does not need to be a full review, so, as the Croydon Local Plan 2018 was only adopted in February 2018, the Local Plan review will consist of a partial review of those policies most affected by the new London Plan (2021) and the National Planning Policy Statement (2023). Details of the Local Plan Partial Review are contained in the table below:
