The premises is a pizza takeaway and there will be no sale of alcohol. CCTV and good lighting has been installed to the premises to prevent crime and disorder. Staff will be trained every 12 months. At least one SIA door supervisor will be deployed on Fridays and Saturdays.

**c) Public safety**

CCTV has been installed. The premises will be kept clean and rubbish will be removed

**d) The prevention of public nuisance**

Staff will be vigilant and trained in conflict management. The staff will keep an incident book and record anti social behaviour inside and outside the premises connected with the Delta Pizza. A quiet notice will be placed at the entrance. Delivery drivers will be requested to switch off their engines when their vehicles are not in use.
