The Croydon (Prohibition and Restriction of Stopping, Loading and Waiting) and (Free Parking Places) (No.31) Order 2024

The Croydon (On-Street Charged-For Parking Places) (No.31) Order 2024

1. NOTICE IS HEREBY GIVEN that Croydon Council on 02 December 2024 made the above Traffic Orders under the relevant sections of the Road Traffic Regulation Act 1984, as amended, and all other enabling powers.
2. **The general effect of the Orders will be:**
  - a) **To introduce “at any time” double yellow line waiting restrictions in the lengths of streets specified in the Schedule to this Notice.**
  - b) **To update the map-based tiles to the Schedule attached to the above Orders to accurately represent the new arrangements as they exist on site.**
3. Copies of the Orders, which will come into operation on 06 December 2024, and of all associated Orders can be inspected by from 9am to 4pm on Mondays to Fridays inclusive until the end of six weeks from the date on which the Orders were made, at the “Access Croydon” Facility, 8 Mint Walk, Croydon, CR0 1EA.

Any person desiring to question the validity of the Orders or of any provision contained therein on the ground that it is not within the relevant powers of the Road Traffic Regulation Act, 1984 or that any of the relevant requirements thereof or of any relevant regulations made there under have not been complied with in relation to the Orders may, within six weeks of the date on which the Orders were made, make application for the purpose to the High Court.

**SCHEDULE**

**(Introducing double yellow line waiting restrictions “at any time”)**

**Brighton Road Service Roads, Coulsdon**

- **The service road at the rear of Nos. 120 to 134 Brighton Road**  
Both sides, between its junction with Malcolm Road and south-western boundary of No. 134 Brighton Road.
- **The service road between Nos. 134 and 136 Brighton Road**  
Both sides, between its junction with Brighton Road and the north-western boundary of No. 136 Brighton Road.
- **The service road running between No. 148 Brighton Road and No. 2 Chipstead Valley Road**  
Both sides, between its junction with Brighton Road and the north-western boundary of No. 148 Brighton Road.
