# Reforms to the Energy Performance of Buildings regime

The Private Sector Housing Team would like to make you aware of a Government consultation. It is open until the 26<sup>th</sup> February 2025. The two Departments running this are the Ministry of Housing, Communities and Local Government and Department for Energy Security and Net Zero.

## Topic of this consultation

This consultation seeks views on the reform of the Energy Performance of Buildings (EPB) framework. It covers the following areas:

- clarifying and consolidating regulations, and focusing on improving the applicability, quality, and data usage of energy certificates in domestic and non-domestic buildings
- updating EPC metrics
- refining requirements for Energy Performance Certificates (EPCs) and Display Energy Certificates (DECs)
- improving data management protocols and strengthening quality control
- revising air conditioning inspection reports (ACIRs)

# Ministry of Housing, Communities and Local Government (MHCLG) – Private Rented Sector (PRS) database

Through the PRS Database, the government aim to collect valuable information from landlords to support local authorities with their enforcement duties and to help tenants make informed decisions about which properties they rent. Landlords will need to register themselves and their properties, alongside documenting information on property standards and interested parties. Local authorities will also be able to upload some offences, such as banning orders. We expect local authorities to have the ability to view all information uploaded through the registration process, with tenants being able to view a subset of this information which is still to be decided. We have heard from landlords that the database could be a useful resource in understanding their responsibilities and keeping up to date with legal obligations. We are keen to speak with landlords to increase understanding and awareness of the

Database, identify how the Database can work for landlords and ensure landlords are compliant once the service is mandatory.

# **National Residential Landlords Association**

The introduction of the Renters' Rights Bill marks a significant change in the private rental sector, focusing on protecting tenants' rights and enforcing stricter landlord responsibilities. The Bill introduces critical changes, including stronger eviction protections, rent regulation measures, and higher standards for rental property maintenance. For landlords, non-compliance with these new rules can result in legal fines, reputational damage, and loss of rental income. This NRLA Training Academy course will help you understand the Renters' Rights Bill in detail, ensuring you remain compliant and equipped to handle your landlord obligations under the new law.

# Have your say on proposed changes to the housing allocation scheme in Croydon

Croydon Council has 13,000 properties it rents to tenants. Every year the Council and Housing Associations provide around 800 new social housing tenancies. These are allocated to new tenants against the priorities determined by the housing allocations scheme. The Council is reviewing its housing allocation scheme to make the process fairer, and clearer for everyone who uses it. The scheme is key as it sets out how we decide the priority or banding on the housing register and explains how you can apply for housing. This may have implications for many residents who live in the private sector.

As part of the review, we are proposing important changes and want to hear what you think about them. Suggested changes include increasing the residency qualification period for social housing in Croydon to 6 years, reviewing banding priorities for care experienced young people and a clearer criteria for accessing sheltered housing. We'd like to hear from all of our stakeholders and partners in the Borough as some of these changes could directly impact on you.

# **Damp and Mould**

Condensation, caused by excess moisture in the air, is the leading cause of damp in homes. Proper ventilation is essential to prevent this, as it allows moisture to escape before it settles on surfaces and turns into condensation, which can lead to mould growth.

With the introduction of *Awaab's Law* under the new Renters Reform Bill, private landlords now have a legal responsibility to address damp and mould concerns promptly and ensure tenants live in safe, healthy homes.

# **Homes for Ukraine**

Croydon Council Homes for Ukraine team continues to require your assistance in securing further private rented sector properties. You will receive a 'Thank you' payment for renting your property directly to guests.

#### Benefits include:

- The council will support tenants with their rent deposit and first month's rent payment.
- The council will pay every landlord who offers a property for a 24-month period, a one-off payment to house our clients. This payment will depend on the size of the property.
- In addition to this, the council will help the tenant to submit an application for housing support and ask that benefits are paid directly into the landlord's bank account.

# Housing Needs and Homelessness New Procurement Team

Housing Needs has set up a new procurement team with the aim of procuring further accommodation to meet the demand from our homeless residents. (Accommodation includes B&B's, longer-term temporary accommodation, and private rented sector units).

The service would like to develop a strong relationship with private sector landlords, local managing and lettings agents and owners of empty properties to secure use of privately rented properties for households in housing. The service will help:

- Negotiate, prepare, sign off lease/management agreements with various providers for different schemes
- To agree all property rates and prices
- To ensure all properties acquired meet housing standards including the requirements of the housing health and safety rating system.
- To conduct regular inspections with accommodation providers (as and when required)
