

DISABLED PERSONS PARKING PLACES – SCHEDULE 242

The Croydon (Prohibition and Restriction of Stopping, Loading and Waiting) and (Free Parking Places) (No. 1) Order 2025

The Croydon (On-Street Charged-For Parking Places) (No. 1) Order 2025

NOTICE IS HEREBY GIVEN that Croydon Council on 03 February 2025 made the above Traffic Orders under section 6 of the Road Traffic Regulation Act 1984, as amended and all other enabling powers.

1. **The general effect of the Orders will be to:**

- a) **Revoke the disabled parking places in the vicinity of No. 10 Capri Road, Croydon, No. 109 Grange Road, South Croydon, No. 3 Grangecliffe Gardens, South Norwood, No. 7 Livingstone Road, Thornton Heath, No. 19 Norbury Crescent, Norbury, 29 Selsdon Avenue, South Croydon, No. 309 Selsdon Road, South Croydon, and No. 41 Woodlands Grove, Coulsdon.**
- b) **Designate new parking places at which vehicles displaying a disabled persons' badge may be left without charge or time limit in the following locations.**

Addiscombe Avenue, Croydon	Outside No. 82
Altyre Road, Croydon	Adjacent to Altitude Apartments, No. 9 Altyre Road (Replaces one space in a payment only bay)
Aurelia Road, Croydon	Outside No. 97
Burlington Road, Thornton Heath	Outside Nos. 78 / 80 and partially across the frontage of Nos. 74 / 76 extending the existing disabled bay by 0.5 metres.
Colescroft Hill, Purley	Outside No. 3
Ena Road, Norbury	Outside No. 5
Fairlands Avenue, Thornton Heath	Outside No. 98
Godric Crescent, New Addington	Outside No. 95
Harcourt Road, Thornton Heath	Outside No. 31 (replaces one space in a permit /payment bay)
Haslemere Road, Thornton Heath	Partially outside Nos. 86 and 88.
Hermitage Lane, Croydon	Adjacent to the flank wall of No. 353 Morland Road.
North Downs Road, New Addington	Outside Nos. 74 to 96
Northwood Avenue, Purley	Outside No. 30 (replaces one space in a free parking bay)
Pollards Crescent, Norbury	Outside Hermione, No. 7
Rockmount Road, Upper Norwood	Outside No. 36
Thomson Crescent, Croydon	Outside No. 24
Tylecroft Road, Norbury	Outside No. 164
Valley Road, Kenley	Outside No. 38
Zion Road, Thornton Heath	Outside No. 58 and partially across the frontage of No. 60 (replaces one space in a permit /payment bay)

- c) **Amend the map-based tiles to the Schedule attached to the above Orders to accurately represent the new parking arrangements as they exist on site.**
2. Copies of the Orders, which will come into operation on 10 February 2025, and of all associated Orders can be inspected between 9am and 4pm, Monday to Friday inclusive, until the last day of a period of six weeks beginning with the date on which the Orders are made at Access Croydon, Bernard Weatherill House, 8 Mint Walk, Croydon, CR0 1EA. Alternatively all related documents or further information can be requested by email to Parking.Design@croydon.gov.uk.
 3. Any person desiring to question the validity of the Orders or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act, 1984 or that any of the relevant requirements thereof or of any relevant regulations made there under have not been complied with in relation to the Orders may, within six weeks of the date on which the Orders were made, make application for the purpose to the High Court.
