To promote the licensing objectives, I will implement the following measures: Prevention of Crime and Disorder: Employing a security officer and installing CCTV. Public Safety: Staff training in responsible alcohol sales and regular safety checks. Prevention of Public Nuisance: Minimizing noise and monitoring customer behavior to

prevent disturbances. These actions will ensure a safe, secure, and responsible environment for customers and staff.

b) The prevention of crime and disorder

To prevent crime and disorder, I will employ a professional security officer during late-night hours and install CCTV cameras, which will be monitored regularly. Staff will be trained to identify and address disorderly behavior, ensuring a safe and secure environment. These measures will help deter criminal activity and maintain a peaceful atmosphere, promoting the safety of both customers and staff.

c) Public safety

A professional security officer, who is also the manager, has been employed to ensure the safety of both customers and staff during extended hours. This proactive measure demonstrates my commitment to maintaining a secure environment, addressing potential safety concerns, and ensuring compliance with all relevant local regulations. The presence of a trained security officer will help prevent incidents and provide a quick response if needed, ensuring public safety at all times.

d) The prevention of public nuisance

To prevent public nuisance, I will minimize noise and ensure customers leave quietly. Staff will be trained to monitor behavior and address issues promptly. Clear signage will remind customers to be considerate of the community. These measures will maintain a peaceful environment inside the premises and in the surrounding area, especially during latenight hours.

e) The protection of children from harm

To protect children from harm, I will strictly enforce the "Challenge 25" policy, requiring identification from any customer who appears under 25 years old. Staff will receive regular training on how to identify and prevent underage sales and will be instructed to refuse service to anyone unable to provide valid ID. The premises will also maintain a safe environment, ensuring that no children are exposed to any harmful or inappropriate activities, in line with local regulations.
