a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

The applicant has run a successful branch of Mr Wong's Wok & Box in Stepney Green since 2017, without incident. The applicant is an experienced premises licence holder and well placed to promote the licensing objectives at the proposed new premises. It is submitted that the conditions proposed below, in addition to the mandatory conditions for premises licences, will be sufficient to ensure the promotion of all four of the licensing objectives.

b) The prevention of crime and disorder

- 1. The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of the Croydon Licensing Team. All entry and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Viewing of recordings shall be made available immediately upon the request of Police or authorised officer throughout the entire 31-day period.
- 2. The CCTV system serving the premises shall:
 - a) be maintained fully operational and in good working order at all times;
 - b) show an accurate date and time that the images were made.
- 3. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises are open. This staff member must be able to provide a Police or authorised council officer copies of recent CCTV images or data with the absolute minimum of delay when requested.

c) Public safety

(The applicant seeks late night refreshment on Fridays and Saturdays only and does not propose to supply alcohol; it is submitted that the mandatory conditions in addition to those proposed above and below will be sufficient to ensure public safety).

d) The prevention of public nuisance

- 1. Notices shall be prominently displayed at all exits requesting patrons to respect the needs of local residents and businesses and leave the area quietly.
- 2. No waste or recyclable materials, including bottles, shall be moved, removed from or placed in outside areas between 22:00 hours and 08:00 hours on the following day.
- 3. During the hours of operation of the premises, the licence holder shall ensure sufficient measures are in place to remove and prevent litter or waste arising or accumulating from customers in the area immediately

outside the premises, and that this area shall be swept and or washed, and litter and sweepings collected and stored in accordance with the approved refuse storage arrangements by close of business.
