ROAD TRAFFIC REGULATION ACT, 1984, SECTION 14 AS AMENDED THE ROAD TRAFFIC (TEMPORARY RESTRICTIONS) ACT 1991 AND ALL OTHER ENABLING POWERS

PURLEY PARK ROAD, BRIGHTON ROAD & MONTPELIER ROAD, PURLEY TEMPORARY PROHIBITION OF VEHICULAR TRAFFIC

- 1. Croydon Council HEREBY GIVE NOTICE that to facilitate telecoms works to replace a joint box frame and cover, they intend to make an Order the effect of which would be to temporarily prohibit traffic movements in Purley Park Road, Brighton Road and Montpelier Road, Purley.
- 2. During the work:
- a) Purley Park Road and Montpelier Road will be closed at their junctions with Brighton Road.
- b) The cycle lane on the south-east (odd-numbered) side of Brighton Road will be closed from the junction with Purley Park Road to the common boundary of No. 2 Purley Park Road and No 859 Brighton Road.
- 3. Whilst the closure remains in force the alternative routes for traffic will be as detailed below. Cyclists affected by the cycle lane closure will be diverted onto the main carriageway.
- Northwest route: Via A235 Brighton Road, Biddulph Road, and Montpelier Road.
- Northeast route: Via A235 Brighton Road, Riddlesdown Road and Purley Park Road.
- Southwest route: Via A235 Brighton Road, Christchurch Road, Whytecliffe Road North, and vice versa.
- Southeast route: Via A235 Brighton Road, Christchurch Road, Pampisford Road, Edgehill Road, Kingsdown Avenue, A235 Brighton Road, Biddulph Road and Montpelier Road.
- Southbound route: Via Montpelier Road, Kingsdown Avenue, Edgehill Road, Pampisford Road, Christchurch Road and A235 Brighton Road.
- 4. The Order will come into operation on 23 July 2025, and it is anticipated that the work will be completed on 25 July 2025. However, the Order will remain in force for 18 months to be reintroduced should further work be required. The prohibition will only apply during such times and to such an extent as shall from time to time be indicated by traffic signs.
- 5. The restrictions shall not apply in respect of:
 - (a) any vehicle involved in conducting the said work.
 - (b) a vehicle being used for fire brigade, ambulance, or police purposes, or the purposes of a statutory undertaker in an emergency, such as the loss of supplies of gas, electricity or water to premises in the area, which necessitates the bringing of vehicles into a section of road to which the order applies.
 - (c) anything done with the permission of a police constable in uniform or a Civil Enforcement Officer.
