

**DISABLED PERSONS PARKING PLACES – SCHEDULE 247**

The Croydon (Prohibition and Restriction of Stopping, Loading and Waiting) and (Free Parking Places) (Amendment No. F14) Order 20-

The Croydon (On-Street Charged-For Parking Places) (Amendment No. F15) Order 20-  
NOTICE IS HEREBY GIVEN that Croydon Council proposes to make the above Traffic Orders under section 6 of the Road Traffic Regulation Act 1984, as amended and all other enabling powers.

**1. The general effect of the Orders would be to:**

- a) **Revoke the disabled parking places in the vicinity of No. 1 Ashley Road, Thornton Heath, No. 64 Beauchamp Road, Upper Norwood, No. 161 Beauchamp Road, Upper Norwood, No. 67 Clarendon Road, Croydon, No. 33 Edward Road, Croydon, No. 181 Gloucester Road, Croydon, No. 32 Grove Road, Thornton Heath, No. 84 Headcorn Road, Thornton Heath, No. 38 Lansdowne Road, Purley, No. 84 Norbury Avenue, Thornton Heath, No 46 Wentworth Road, Croydon, and No. 7 Western Close, Coulsdon.**
- b) **Designate new parking places at which vehicles displaying a disabled persons' badge may be left without charge or time limit in the following locations.**

<b>Grangecliffe Gardens, South Norwood</b>	<b>Outside No. 7</b>
<b>Harewood Gardens South Croydon</b>	<b>Outside No. 23</b>
<b>Holmewood Road, South Norwood</b>	<b>Outside No. 17 and partially across the frontage of No. 19</b>
<b>Lucerne Road, Thornton Heath</b>	<b>Outside No. 18 and partially across the frontage of No. 16</b>
<b>Lucerne Road, Thornton Heath</b>	<b>Outside No. 65</b>
<b>Lyndhurst Road, Thornton Heath</b>	<b>Outside No. 63</b>
<b>Penrith Road, Thornton Heath</b>	<b>Outside No. 18 and partially across the frontage of No. 20</b>
<b>Pitt Road, Croydon</b>	<b>Outside No. 3 and partially across the frontage of No. 1 (replaces one space in a permit/payment bay)</b>
<b>Redford Avenue, Thornton Heath</b>	<b>Outside No. 11</b>
<b>The Waldrons, Croydon</b>	<b>Outside No. 16 and partially across the frontage of No. 15 (replaces one space in a permit/payment bay)</b>
<b>Tunstall Road, Croydon</b>	<b>Outside No. 89 and partially across the frontage of No. 87 (replaces one space in a permit/payment bay)</b>
<b>Upton Road, Thornton Heath</b>	<b>Outside No. 35</b>

- c) **Amend the map-based tiles to the Schedule attached to the above Orders to accurately represent the new parking arrangements as they exist on site.**
2.
