Yahso Seafood Restaurant commits to a safe, well-managed environment. Staff receive ongoing training on licensing laws, safeguarding, public safety, and nuisance prevention. We will cooperate with Croydon Council and authorities to ensure compliance and promptly address any issues.

b) The prevention of crime and disorder *

We enforce Challenge 25 to prevent underage sales. Staff are trained to refuse service to intoxicated customers. CCTV covers public areas with recordings kept for 31 days. Incident logs are maintained. SIA door staff will be used if ever needed. We cooperate with police to prevent crime,

c) Public safety *

We comply with health and safety laws, conduct fire risk assessments, and train staff in emergencies. Emergency exits are marked and clear. Capacity limits are monitored to prevent overcrowding. First aid trained staff are available during all opening hours.

d) The prevention of public nuisance *

Noise levels and customer behavior are controlled to avoid disturbance. Doors/windows closed after 10 pm where possible. Outdoor areas are managed to reduce noise. Customers are reminded to leave quietly. Waste is regularly cleared to prevent litter and pests.

e) The protection of children from harm *

Challenge 25 is strictly enforced. Children must be supervised at all times and are not allowed unaccompanied after 6pm. No adult entertainment is provided. Staff are trained to safeguard children and ensure a safe, family-friendly environment.
