

Statement of Representation Procedure: Community Infrastructure Levy Charging Schedule Review

Notice under Regulation 16 of the Community Infrastructure Levy Regulations 2010: Publication of a draft charging schedule

London Borough of Croydon (Council) intends to submit a Community Infrastructure Levy (CIL) Draft Charging Schedule for examination, under Section 212 of the Planning Act 2008 (as amended by the Localism Act 2011).

Persons making representations may request the right to be heard by an examiner. If you wish to be heard during the examination process, please indicate this in your representation.

You may also request in the representation to be notified at later stages, including:

- that the draft charging schedule has been submitted to the Examiner in accordance with the Planning Act 2008,
- the publication of the recommendations of the examiner and the reasons for those recommendations, and
- the approval of the charging schedule by the charging authority.
