ROAD TRAFFIC REGULATION ACT, 1984, SECTION 14  
AS AMENDED AND THE ROAD TRAFFIC (TEMPORARY RESTRICTIONS) ACT 1991  
DUNBAR AVENUE, CRAIGNISH AVENUE, DALMENY AVENUE, EDERLINE AVENUE,  
MELROSE AVENUE & KILMARTIN AVENUE, NORBURY - TEMPORARY RESTRICTION OF  
TRAFFIC

1. Croydon Council HEREBY GIVES NOTICE that to facilitate gas main replacement works by SGN, they have made an Order the effect of which would be to temporarily restrict traffic in Dunbar Avenue, Craignish Avenue, Dalmeny Avenue, Ederline Avenue, Melrose Avenue and Kilmartin Avenue, Norbury.
2. Whilst the said works are taking place the sections of road below will be closed on the dates shown.

Dunbar Avenue	Between Ederline Avenue & Melrose Avenue	09February to 22 February 2026
Ederline Avenue	At its junction with Dunbar Avenue	09February to 22 February 2026
Dunbar Avenue	Between Melrose Avenue & Kilmartin Avenue	23 February to 01 March 2026
Melrose Avenue	At its junction with Dunbar Avenue	23 February to 01 March 2026
Dunbar Avenue	Between Kilmartin Avenue & Strathyre Avenue	02 March to 09 March 2026
Kilmartin Avenue	At its junction with Dunbar Avenue	02 March to 09 March 2026

3. During the closures, the alternative routes for vehicular traffic will be as detailed below.
  - Dunbar Avenue Northbound: Via Norbury Crescent, St Helens Road, London Road, and Ederline Avenue.
  - Dunbar Avenue Westbound: Via Ederline Avenue, London Road, and Norbury Crescent.
  - Craignish Avenue Northbound: Via London Road and Ederline Avenue.
  - Dalmeny Avenue Eastbound: Via Norbury Crescent, St Helens Road, and London Road.
  - Ederline Avenue Westbound: Via Ardfern Avenue and Melrose Avenue.
  - Ederline Avenue Eastbound: Via Dalmeny Avenue.
  - Melrose Avenue Northbound: Via Ardfern Avenue and Ederline Avenue.
  - Melrose Avenue Southbound: Via Ardfern Avenue and Kilmartin Avenue.
  - Kilmartin Avenue Northbound: Via Ardfern Avenue and Melrose Avenue.
  - Kilmartin Avenue Southbound: Via Ardfern Avenue and Strathyre Avenue.
4. The Order will come into operation on 26 January 2026, and it is anticipated that the works will be completed as above. However, the Order will remain in force for 18 months to be reintroduced should further work be required.

5. These restrictions shall not apply in respect of:
- (a) a vehicle being used for fire brigade, ambulance, or police purposes, or the purposes of a statutory undertaker in an emergency, such as the loss of supplies of gas, electricity or water to premises in the area, which necessitates the bringing of vehicles into a section of road to which the order applies.
  - (b) anything done with the permission of a police constable in uniform or a Civil Enforcement Officer.
  - (c) any vehicle involved in carrying out the specified works.
