The Croydon (Prohibition and Restriction of Stopping, Loading and Waiting) and
(Free Parking Places) (Amendment No. H1) Order 20-

The Croydon (On-Street Charged-For Parking Places) (Amendment No. H2) Order 20-

NOTICE IS HEREBY GIVEN that Croydon Council proposes to make the above Traffic Orders under section 6 of the Road Traffic Regulation Act 1984, as amended and all other enabling powers.

1. The general effect of the Orders would be to:

- a) **Revoke the disabled parking places in the vicinity of: No. 23 Boswell Road, Thornton Heath, No. 470 Chipstead Valley Road, Coulsdon, No. 89 Coleridge Road, Croydon, No. 34 Ferndale Road, South Norwood, No. 56 Leander Road, Thornton Heath, No. 76 Malvern Road, Thornton Heath, No. 185 Norbury Crescent, Norbury, No. 10 to 17 Underwood, Field Way, Croydon, Nos. 4 and 6 Redstart Close, New Addington, and No. 33 Tugela Road, Croydon.**
- b) **Designate new parking places at which vehicles displaying a disabled persons' badge may be left without charge or time limit in the following locations.**

Arundel Close, Croydon	Outside No. 11 and partially across the frontage of No. 12 (bay at 90 degrees to the kerb).
Aurelia Road, Croydon	Outside No. 45 and partially across the frontage of No. 47 (replaces one space in a permit/payment bay)
Beauchamp Road, Upper Norwood	Outside No. 64 and partially across the frontage of No. 62
Brickfield Road, Thornton Heath	Outside No. 7
Chelsham Road, South Croydon	Outside No. 29 and partially across the frontage of No. 31
Colebrook Road, Norbury	Outside No. 1
Field Way, New Addington	Adjacent to the footpath running between Nos. 166 and 114 Field Way
Hartley Road, Croydon	Outside No. 59 (replaces one space in a permit/payment bay).
Heathview Road, Thornton Heath	Outside Nos. 12 and 14
Isham Road, Norbury	Outside No. 79
Kynaston Crescent, Thornton Heath	Outside No. 16 (replaces one space in a partial footway permit/payment bay).
Longheath Gardens, Croydon	In the inset parking bay opposite Nos. 149/159 (bay at 90 degrees to the kerb).
Lucerne Road, Thornton Heath	Outside No. 49 and partially across the frontage of No. 47
Lyndhurst Road, Thornton Heath	Outside No. 1
Mersham Road, Thornton Heath	Outside Nos. 161 and 163
Mitcham Road, Croydon	Outside No. 539 and partially across the frontage of No. 541
Nicola Close, South Croydon	Adjacent to the flank wall of No. 30 Nicola Close
Oval Road, Croydon	Adjacent to the flank wall of Oval House, No. 1 Oval Road (replaces one space in a permit/payment bay)
Silverleigh Road, Thornton Heath	Outside No. 111 and partially across the frontage of No. 113 (partial footway bay)
Silverleigh Road, Thornton Heath	Outside No. 119 and partially across the frontage of No. 121 (partial footway bay)
Silverleigh Road, Thornton Heath	Outside 121 and partially across the frontage of No. 123 (partial footway bay - relocating the bay currently outside Nos. 123 and 125)
Teevan Road, Croydon	Outside No. 59
Witley Crescent, New Addington	Adjacent to the flank wall of No. 117 Headley Drive

2.
