

PN471 - CROYDON COUNCIL
ROAD TRAFFIC REGULATION ACT, 1984, SECTION 14 AS AMENDED
THE ROAD TRAFFIC (TEMPORARY RESTRICTIONS) ACT 1991
AND ALL OTHER ENABLING POWERS
BARTLETT STREET, BRIGHTON ROAD, CROHAM ROAD, NOTTINGHAM ROAD,
SELSDON ROAD, & ST PETER'S STREET, SOUTH CROYDON
TEMPORARY PROHIBITION OF TRAFFIC & PARKING

1. Croydon Council HEREBY GIVE NOTICE that to facilitate ducting works by UKPN, they intend to make an Order the effect of which would be to temporarily prohibit traffic movements and parking in the above roads in South Croydon.
2. During the works:
 - a) The left turn lane from Bartlett Street into Brighton Road will be closed and turning left from Bartlett Street into Brighton Road will be banned.
 - b) The lane that allows vehicles to turn left from Selsdon Road into Bartlett Street will be closed between the Roundabout at the junction with Croham Road and the junction with Bartlett Street.
 - c) Croham Road will be closed between its junction with South Park Hill Road and the Roundabout at the junction with Selsdon Road.
 - d) The southbound lane of Brighton Road will be closed at its junction with Bartlett Street.
 - e) One-way working in St. Peters Street will be suspended.
 - f) The cycle lane on the east side of Brighton Road north of its junction with Bartlett Street will be closed.
 - g) Parking will be suspended and waiting and loading restrictions will apply at any time in the following sections of road:
 - i) Brighton Road for 20 metres either side of its junction with Bartlett Street.
 - ii) Bartlett Street within 20 metres of its junction with Brighton Road.
 - iii) Nottingham Road within 20 metres of its junction with Brighton Road.
 - iv) Croham Road between its junction with South Park Hill Road and the Roundabout at the junction with Selsdon Road.
 - v) Selsdon Road for 20 metres either side of its junction with Croham Road.
3. Whilst the closures remain in force the alternative routes for diverted vehicles will be as detailed below.
 - Bartlett Street closure - via Warham Road, Nottingham Road and Brighton Road.
 - Selsdon Road closure - via B275, Aberdeen Road and Brighton Road
 - Croham Road closure - via South Park Hill Road, Coombe Road and St Peters Road.
4. The Order will come into operation on 13 April 2026, and it is anticipated that the work will be completed within approximately five weeks. However, the Order will remain in force for 18 months to be reintroduced should further work be required. The prohibitions will only apply during such times and to such extent as shall from time to time be indicated by traffic signs.
5. The restrictions shall not apply in respect of:
 - (a) any vehicle involved in conducting the said work.
 - (b) a vehicle being used for fire brigade, ambulance, or police purposes, or the purposes of a statutory undertaker in an emergency, such as the loss of supplies of gas, electricity or water to premises in the area, which necessitates the bringing of vehicles into a section of road to which the order applies.
 - (c) anything done with the permission of a police constable in uniform or a Civil Enforcement Officer.
