ROAD TRAFFIC REGULATION ACT, 1984, SECTION 14 AS AMENDED  
THE ROAD TRAFFIC (TEMPORARY RESTRICTIONS) ACT 1991  
AND ALL OTHER ENABLING POWERS  
WOODCOTE DRIVE, PEAKS HILL & PEAKS HILL RISE, PURLEY  
TEMPORARY PROHIBITION OF VEHICULAR TRAFFIC

1. Croydon Council HEREBY GIVE NOTICE that to facilitate gas main connection and renewal works, they have made an Order the effect of which would be to temporarily prohibit traffic movements on the roads below, as detailed.

2. Whilst the said work is taking place, phased closures will apply to the roads below.

<b>Road to be closed</b>	<b>Extent of closure</b>	<b>Dates of Closures</b>
Woodcote Drive	Entire Road	29 June – 20 July 2026
Peaks Hill	Entire Road	06 July – 01 September 2026
Peaks Hill Rise	Entire Road	17 August – 04 September 2026

3. During the works the diversion routes for vehicular traffic will be as detailed below.

- **Woodcote Drive closure** – Via The Ridge, Farm Lane, and Green Lane, or via Great Woodcote Park, Church Road, and Peaks Hill.
- **Woodcote Drive closure** – Via Green Lane, Farm Lane, and Foxley Lane, or via Peaks Hill, Peaks Hill Rise, and Foxley Lane.
- **Peaks Hill closure** – Via Woodcote Drive, Great Woodcote Park, and Church Road, or via Woodcote Drive, Foxley Lane, and Peaks Hill Rise.
- **Peaks Hill closure** – Via Woodcote Drive, Great Woodcote Park, and Church Road, or via Plough Lane, The Bridle Road, Foxley Lane and Peaks Hill Rise.
- **Peaks Hill closure** – Via Church Road, Church Hill, and Plough Lane, or via Peaks Hill Rise, The Bridle Road, and Plough Lane.
- **Peaks Hill Rise closure** – Via Peaks Hill, Woodcote Drive, and Foxley Lane, or via Peaks Hill, Plough Lane, The Bridle Road, and Foxley Lane.

4. The Order will come into operation on 29 June 2026, and it is anticipated that the works will be completed as detailed above. However, the Order will remain in force for 18 months to be reintroduced should further work be required. The prohibitions will only apply during such times and to such extent as shall from time to time be indicated by traffic signs.

5. The restrictions shall not apply in respect of:

- (a) a vehicle involved in conducting the said work.
- (b) a vehicle being used for fire brigade, ambulance, or police purposes, or the purposes of a statutory undertaker in an emergency, such as the loss of supplies of gas, electricity, or water to premises in the area, which necessitates the bringing of vehicles into a section of road to which the Order applies.
- (c) anything done with the permission of a police constable in uniform or a Civil Enforcement Officer.
